

主要统计指标解释

文化事业机构 指从事专业文化工作和为专业文化工作服务的独立建制的单位。不包括这些单位另外举办独立核算的其他机构和各部门的业余文化组织。

艺术表演团体 指从事戏曲、音乐、舞蹈、杂技等专业艺术表演,有独立账户的单位,不包括半工半艺、半农半艺和民间职业剧团。

等级运动员人数 指经考核正式批准授予等级运动员称号的人数。运动员等级分为国际级运动健将、运动健将、一级运动员、二级运动员、三级运动员、少年级运动员。

等级裁判员人数 指经考核正式批准授予等级裁判员称号的人数。裁判员等级分为国际裁判、国家级裁判、一级裁判、二级裁判、三级裁判。

卫生机构 指从卫生计生行政部门取得《医疗机构执业许可证》,或从民政、工商行政、机构编制管理部门取得法人单位登记证书,为社会提供医疗保障、疾病控制、卫生监督服务或从事医学科研和教育等工作的单位。

卫生技术人员 指卫生事业机构支付工资的全部职工中现任职务为卫生技术工作的专业人员,包括执业医师、执业助理医师、注册护士、药剂人员、检验人员和其他卫生技术人员。

执业(助理)医师和注册护士 指领取医师执业证书和注册护士证书的人员。

Explanatory Notes on Main Statistics Indicators

Cultural Institutions refer to units which have their own organizational system and independent accounting system and specialize in or serve cultural development. They exclude other establishment ran by these cultural institutions and amateur groups established by various departments.

Art Troupe refer to the troupe which is engaged in drama, opera, music, dance, acrobatics or other art performance, opens independent accounts with banks and has self-accounting system ; excluding the troupes which are engaged partly in industrial or agricultural activities, partly in art performance and the professional troupes organized by the people.

Number of Athletes in Grades refers to the number of athletes who have been given titles through examination. The titles of athletes include international masters of sports, masters of sports, first grade, second grade and third grade sportsmen and young athletes.

Number of Referees in Grades refers to the number of referees who have been given titles after examination. They are classified as international referees, national referees and referees of the first, second and third grades.

Health Care Institutions refers to the units which have received the “Practitioner Licence Certification of Medical and Health Institutions” from health administration, or the registered certification of corporation units from the civil, industrial and commercial, and establishment administration. They provide the services of medical security, disease controlling, health supervision, or engaged in medical scientific research and education.

Medical Technical Personnel refer to all medical staff and workers employed by medical institutions, including doctor of Chinese and Western medicine, senior doctors who integrated traditional Chinese therapeutics with Western therapeutics in practice, senior nurses, pharmacists of Chinese and Western medicine, laboratory specialists, other specialists, paramedics of Chinese and Western medicine, nurses, midwives, druggists in Chinese and Western medicine, laboratory technicians, other technicians, other practitioners of Chinese medicine, nursing attendants, pharmacological workers of Chinese and Western medicine, laboratory workers and other primary medical personnel.

Practitioner (Assistant) Doctor and Registered Nurse refer to the doctors and nurses who have received the practitioner doctor certification and registered nurse certification respectively.
